

Terms of Use Agreement

Effective: February 6, 2020

1. Acceptance of the Terms and Conditions.

1.1 TTSF, Inc. (dba Pathlight) (herein referred to as "Pathlight," "we," "us" or "our") provides and makes available this site located at www.pathlight.com (the "Site"). All use of the Site is subject to the terms and conditions contained in this Terms of Use Agreement (the "Agreement"). Please read this Agreement carefully. By accessing, browsing or otherwise using the Site, you acknowledge that you have read, understood, and agree to be bound by this Agreement.
